

Evangelism Committee Meeting Summary

FINANCE REPORT:

- Finance reports from May and June were reviewed.

OLD BUSINESS:

- Deaconess Grant Plans
 - Gale Bolen reported on plans to offer exercise workout program aimed at people ages 50- 80. There was discussion as to which organization to use and the details of the program. It was decided to use Apex, since they would provide all the necessary equipment. It was also decided to offer the program for once a week for 12 weeks at no cost to the participants.
 - Waiting to hear back from CPR trainers for a date to recertify those who took CPR training two years ago.
 - Will continue to look into offering Health Screening.
- Vision and Mission Statement Discussion
 - Pastor Jerry will lead the process at a later date, since there was only one member who attended the Long Range Planning seminar.
- Volunteers for Fellowship Hour
 - Worship Committee will do Fellowship Hour the first two Sundays in July and Board of Christian Education will do the last three weeks. Women's Guild will do Fellowship Hour the month of August and Evangelism Committee will do the first Sunday in September, which will be the last Sunday of Fellowship Hour before returning to Worship at 10:00.

She has agreed to make donuts the last Sunday of each month in the summer.
